



Transfer Request for GS1 US Identifiers

Instructions and Form

Use this form to initiate the transfer of any identifier licensed by GS1 US®: GS1 Company Prefix, GS1 US Global Trade Item Number (GS1 US GTIN) or Global Location Number (GLN).

Important Considerations

- Please note that submitting this form and supporting documentation does not guarantee transfer of an identifier. Each request is unique and, in some cases, may take additional time to review.
- A single transfer request can include multiple identifiers as long as:
The request to transfer all identifiers is just between two companies: the company that currently holds the licenses to the identifiers and the company requesting the licenses to the identifiers moving forward.
- For prefix transfers: A prefix needs to be transferred in its entirety. Partial transfers or splits of prefixes are not permitted.
- For GTIN transfers (product identifiers): A GTIN can only be transferred when not associated with a licensed prefix.
- For GLN transfers (location identifiers): A GLN can only be transferred when not associated with a licensed prefix.

Step	Instructions
1	Fill out the form on the next page completely. <ul style="list-style-type: none">• Use full legal company names (no DBAs, assumed names, or fictitious names).
2	Prepare appropriate supporting documentation. <ul style="list-style-type: none">• This includes an Identifier Release Letter signed by an authorized officer of the company that currently holds the license to the identifiers requested to be transferred.• If you cannot get this signed Identifier Release Letter, the identifiers may still be transferred if you provide other legal documentation.• Applicable supporting documents include but are not limited to signed transactional documents that evidence the sale of the business, sale of the business line, or merger with another company.
3	Submit your request. <ul style="list-style-type: none">• Email the fully completed form and all supporting documents to dmaintenance@gs1us.org.
4	Add dmaintenance@gs1us.org to your contacts or safe sender list to ensure GS1 US emails don't get filtered and that you receive all responses and updates.
